JUDGMENT OF CONVICTION

Defendant appears in person and by counsel, **Mr. Hammond**. State appears by Deputy Prosecuting Attorney . Defendant having entered a plea of guilty pursuant to plea agreement, sentencing hearing is held.

The Court, having considered the written Pre-Sentence Investigation Report and [the Probable Cause Affidavit as confirmed by the Defendant] having heard and considered evidence, now finds:

1. That the plea agreement is accepted.

2. Defendant is guilty of:

II 35-42-4-6(a)(1)(c)/F5: Child solicitation by a person at least (21) years of age

3. That the following circumstances are aggravating/mitigating circumstances:

COUNT II: IT IS THEREFORE ORDERED that the Defendant be committed to the Indiana Department of Correction for classification and confinement for a period of 5 years, provided, however, that said sentence of imprisonment is ordered suspended and Defendant placed on active adult probation for a period of 4 years, subject to the standard conditions of probation and special conditions of probation executed this date and filed herein. Probation User's Fees assessed.

Defendant is ordered to pay restitution in the sum of \$ ____.

Defendant is granted credit for 8 days served in jail.

— License, plates and registration are suspended for 180 days.

— Executed sentence is to be served in the Allen County Community Corrections Home Detention program.

Defendant to successfully complete all recommended rehabilitative interventions, including the Addictions Residential Program per clinical assessment.

— Executed sentence is to be served in the Allen County Community Corrections Residential Services. Supervision to include electronic monitoring. Defendant ordered to participate in and successfully complete all required assessment(s) and rehabilitative services while under the supervision of ACCC.

Defendant is fined in the sum of \$0 together with court costs which include the following:
